### Participate and return home with solutions:

This International Master Class will on the one hand bring together laboratory personnel who are responsible for the implementation, maintenance, improvement and operation of the laboratory management system, with experienced international trainers. They will discuss and most importantly investigate how to apply the revised international standard ISO/IEC 17025.

Similar classes were organised in April 2018 in Zagreb and in December 2018 and April 2019 in Brussels, with participants from many different countries sharing and discussing their issues and experiences.

The focus of this three day event will be the practical application of the new standard. The intention is to have a very interactive course, with problem based learning. Participants will leave with the knowledge and the skills to progress from theory into practical application and to discover what is the most cost effective way to adapt the standard to their organisation. They will also have an opportunity to discuss with the trainers and their peers on the very specific issues they are struggling with.

### Aim:

At the end of this master class, you will be able to

- INTERPRET the changes needed to manage the transition of your laboratory management system
- SET UP a plan of what to undertake inside your organisation in the next year
- FACILITATE implementation of risk based thinking
- IMPLEMENT requirements of the new standard effectively

### Who should attend?

- Laboratory personnel who are responsible for the implementation, maintenance, improvement or operation of the laboratory management system
- Laboratory assessors and internal auditors
- Laboratory staff involved in training colleagues
